## **Data protection information obligations according to Article 13 DS-GVO**

### **Purpose and legal basis of the processing**

The processing of the image material (collection, storage and transfer to third parties) is based on the explicit consent of the person(s) concerned or the person's legal guardian(s) according to Art. 6 (1a) DS-GVO within the scope of the purpose of consent.

### **Categories of recipients of the personal data**

If necessary, the photographic material will be passed on to the commissioned agencies for the creation and publication of print and online publications. In context of uploading the photographic material to social networks, the photographic material will be passed on to the relevant providers of the social networks.

### **Duration of the storage of personal data**

Subject to revocation of the consent of the person(s) concerned, the image material will be stored in the image database of HOOP-CAMPS e.V. for an indefinite period of time.

### **Right of revocation of consent**

The consent to the processing of the image material can be revoked at any time with effect for the future. The revocation must be made in written form (e.g. letter, e-mail, fax) to the above contact details of the responsible person.

### **Data subject rights**

According to the General Data Protection Regulation, you have the following rights:

- If your personal data is processed, you have the right to receive information about the data stored about you (Article 15 DS-GVO).
- If inaccurate personal data is processed, you have the right to rectification (Article 16 DS-GVO).
- If the legal requirements are met, you may request the erasure or restriction of processing as well as object to processing (Article 17, 18, 21 DS-GVO).
- If you have consented to the data processing or if a contract for data processing exists and the data processing is carried out with the help of automated procedures, you may have a right to data portability (Article 20 DS-GVO).
- Furthermore, you have the right to lodge a complaint with the North Rhine-Westphalia State Commissioner for Data Protection and Freedom of Information (LDI-NRW).
